Reporting Students with Unexcused Absences (O.C.G.A. 20-2-701)

Consequences for Unexcused Absences

- Any parent, guardian, or other person who has control of any child who on the **tenth unexcused** day of absence per semester and after the child's school system has notified the parent, guardian, or other person who has control of any child, upon each day's absence/tardy from school shall be guilty of a misdemeanor and court action may be pursued for formal intervention.
- **Penalties:**
 - 1) **Fine** – not less than \$25 and not greater than \$100.00
 - 2) **Imprisonment** – not to exceed 30 days
 - 3) **Community Service or any combination of such penalties, at the discretion of the court.**

Absences – Lawful absences (excused) as defined by State Board of Education Rule 160-5-1-.10 Student Attendance:

- Personal Illness
- Death in immediate family
- Religious Holiday
- Instances in which attendance could be hazardous as determined by the Fayette County School System
- Service as page in legislature
- Court Order
- Absence to vote in an election
- Up to five (5) days excused absences per year to students whose parents are in the military and are being deployed or are on leave.

Attendance/Discipline and Driver's License – (O.C.G.A. 40-5-22)

Committing any of the following offenses will result in the Georgia Department of Driver Services not issuing an instructional permit or driver's license. If a student has already been issued an instructional permit or driver's license, the department will suspend that permit/license or the ability to receive one, for a period of **one year**. This notification will be made by certified mail.

- A. Has dropped out of school without graduating and has remained out of school for ten consecutive school days;
- B. Has **ten or more** school days of **unexcused absences** during the current academic year or ten or more school days of unexcused absences in the previous academic year; or
- C. Has been found in violation by a hearing officer, panel, or tribunal of one of the following offenses, has received a change in placement for committing one of the following offenses, or has waived his/her right to a hearing and pleaded guilty to one of the following offenses:
 - I. Threatening, striking or causing bodily harm to a teacher or other school personnel;
 - II. Possession or sale of drugs or alcohol on school property or at school sponsored event;
 - III. Possession or use of a weapon on school property or at school sponsored event.
 - IV. Any sexual offense prohibited under Chapter 6 of Title 16: or;
 - V. Causing substantial physical or visible bodily harm to or seriously disfiguring another person, including another student.

Consecuencias por ausencias no excusadas

- Cualquier padre o encargado(a) del estudiante que se ausenta sin excusa válida por la décima vez en un semestre, y luego de ser notificado por el sistema escolar, a dicho padre o encargado se le formularán cargos de delitos menores y se le podría tomar acción de corte como medio para prevenir ausencias.
- **Penalidades:**
 1. **Multas**- No menos de \$25.00 pero no mayor de \$100.00
 2. **Encarcelamiento**- No más de 30 días
 3. **Servicios comunitarios o una combinación de dichas penalidades, a discreción de la corte.**

 - Se otorga hasta (5) días al año a estudiantes cuyos padres sirven en las fuerzas armadas del ejército de los EEUU por motivo a que el padre/ la madre sean movidos de lugar o estén de pase militar.

Asistencia Escolar/Disciplina y La Licencia o Carné de Conducir- (O.C.G.A. 40-5-22)

Cometer cualquiera de los delitos mencionados resultará en la negación del permiso de conducir o la negación de la licencia de conducir. Si acaso el estudiante ya tiene el permiso o la licencia de conducir y comete dichos delitos, se le revocará o se le suspenderá la licencia por **un año**. Se le notificará por medio de correo certificado. Los delitos son los siguientes:

- A. Haber abandonado la escuela sin haberse graduado o ha estado fuera de la escuela por diez días consecutivos.
 - B. Tener diez o más de diez días de ausencias no excusadas durante el corriente año escolar o diez días o más de ausencias no excusadas del año escolar anterior; o
 - C. Haber sido encontrado culpable de haber violado una vista con el oficial, el panel, o el tribunal por una de las siguientes ofensas:
 - I. Amenaza, causar daño físico o agresión corporal a un maestro u oficial escolar;
 - II. Posesión o venta de drogas o alcohol en propiedad escolar o evento escolar;
 - III. Posesión o venta de armas en propiedad escolar o evento escolar;
 - IV. Cualquier delito o ofensa sexual prohibida bajo del capítulo 6 del Título 16: o,
 - V. Causar serio daño corporal sea físico o emocional que cause el desfiguramiento de otra persona, e incluye a otro estudiante.
- (4) Si acaso el padre/encargado NO desea que su hijo(a) participe de clubes u organizaciones designadas por el estudiante, favor de identificar estos clubes o Organizaciones en el espacio en blanco al final de la hoja.

Código Sobre La Vestimenta Estudiantil

El Condado De Las Escuelas Publicas de Fayette requiere que todo estudiante vista y cuide de su aseo personal tal que refleje nitidez, limpieza, y el buen gusto. La vestimenta estudiantil no debe ser atrayente o que cause distracción o que cause interrupción a programa educativo o a la orden escolar. Los administradores escolares serán encargados de determinar las violaciones al código de la vestimenta estudiantil. El principal o director escolar reserva todo el derecho de interpretar o añadir o hacer provisiones de determinar el mejor interés escolar, del estudiante y del proceso educativo.

Algunas vestimentas no son apropiadas para el ambiente escolar. Las siguientes destacan vestimenta escolar **no apropiada**:

1. Camisas/ blusas y/o vestidos que **no** cubren la cintura, los hombros, y la espalda (Camisas/blusas deben cubrir la espalda y los hombros completamente).
2. Las camisas, las blusas, y los trajes de manguillos no son apropiados para la escuela
3. Los pantalones largos, cortos, las faldas, las camisetas, y camisas de talla inapropiada o con Rotos o descosidos (no deben ser tan largos que Toquen el piso)
4. La medida correcta para los vestidos, las faldas, y los pantalones es que no deben de ser más altos que las puntas de sus dedos al poner los brazos al lado del cuerpo
5. La ropa interior expuesta o a la vista no será permitida
6. No usar ropa interior es considerado una violación al código
7. Ropas que anuncian algún anuncio sugestivo, o lenguaje inapropiado, o anuncios de drogas, alcohol, tabaco, o sexo; u otros como mensajes/fotografías que glorifican o promueven la violencia o la muerte
8. La ropa transparente y/o tejida sin uso de ropa interior apropiada
9. Abrigo o chaqueta de doble botones en el pecho
10. Ropa reveladora no será aceptada
11. Ropa ceñida al cuerpo (i.e. expandes)
12. Pantalones vaqueros o jeans cortados o rotos
13. Ropa de dormir/pijamas/pantufilas de casa
14. Los lentes de sol no serán permitidos dentro del edificio escolar
15. Cadenas; monederos de cadenas que puedan causar daño personal u a otros
16. diademas y sombreros (Sombreros o gorras y capacetes deben de permanecer en su armario o locker)
17. Bananas y otro tipo de cubre cabeza
18. Ropa relacionada, con símbolos o con insigne de gangas
19. Perforaciones en el cuerpo que posen peligro o causen disrupción – **(vea nota adicional)**

FAYETTE COUNTY SCHOOL SYSTEM

Secondary Level

2007-2008

Foreword

It is the purpose of the Fayette County School System to operate each school in a manner that will provide an orderly process of education that ensures the welfare and safety of all students who attend the schools within the district. In accordance with that purpose, the Board of Education has adopted a policy that requires all schools to provide codes of conduct. These standards of behavior require students to conduct themselves at all times in a manner that facilitates an optimum learning environment for themselves and others.

We expect students to:

- Respect each other
- Respect school district employees
- Obey student behavior policies adopted by the Board of Education
- Obey rules established by individual schools

The school's primary goal is to educate, not to punish; however, when the behavior of an individual student comes in conflict with the rights of others, corrective actions may be necessary for the benefit of that individual and the school as a whole. Accordingly, students shall be governed by policies, regulations and rules set forth in this Code of Conduct.

The Code of Conduct is effective during the following times and in the following places:

- At bus stop
- At school or on school property at any time
- Off school property at any school activity, function or event and while traveling to and from such events
- On vehicles provided for student transportation by the school system

Also, students may be disciplined for felonious conduct off campus which may pose a threat to the school's learning environment or the safety of students and employees.

Parents are encouraged to become familiar with the Code of Conduct and to be supportive of it in their daily communication with their children and others in the community. We ask your cooperation in sharing this responsibility for maintaining a proper learning environment.

Authority of the Principal

The principal is the designated leader of the school and, in concert with the staff, is responsible for the orderly operation of the school. In cases of disruptive, disorderly or dangerous conduct not covered in this Code, the principal may undertake corrective measures which he or she believes to be in the best interest of the student and the school provided any such action does not violate school board policy or procedures.

Students Should:

Participate fully in the learning process. Students need to report to school and class on time, attend all regularly scheduled classes, remain in class until excused or dismissed, pay attention to instruction, complete assignments to the best of their ability, and ask for help when needed.

Avoid behavior that impairs their own or other students' educational achievement. Students should know and avoid the behaviors prohibited by this code, take care of books and other instructional materials, and cooperate with others.

Show respect for the knowledge and authority of teachers, administrators, and other school employees. Students must obey reasonable directions, use acceptable and courteous language, avoid being rude and follow school rules and procedures.

Recognize and respect the rights of other students and adults. All students should show concern for and encouragement of educational achievements and participation of others in curricular and extra-curricular activities.

Disciplinary action for violations of expected behaviors will include appropriate hearings and reviews. In all cases, the rights of individuals will be ensured and protected. The Fayette County School System will make every reasonable effort to administer the discipline code consistently in all schools. When applicable, individualized plans (i.e. IEP, 504, and SST) will be reviewed for appropriate consequences.

Admission Requirements

Age Requirements

- Students who are five years of age on or before September 1 are eligible for entrance to kindergarten.
- Students who are six years of age on or before September 1 are eligible for entrance to first grade.

Attendance Areas

Students must attend the school which lies within the attendance area where their parent/legal guardian resides. Students may not attend other schools in the system except with the permission of Fayette County Board of Education.

If the parent/guardian moves to another attendance area within the county after the start of the school year, the parents/guardians have the option of allowing their children to remain at their current school for the remainder of the school year. In such cases, the parents/guardians must receive written approval from School Operations for their children to attend school out of their assigned attendance area. Acceptable behavior and attendance, to include on time arrival, are required in order for this permission to remain valid. Bus transportation will not be provided. At the beginning of the next school year, the parents/guardians are required to enroll their children in the school they are assigned to attend based on the location of their residence.

School Reassignment

Parent/guardian interested in Special Permission for a student(s) to attend school out of the assigned attendance area should first review the current School Board Policy (JBCCA) regarding Assignment of Students to Schools. The Special Permission deadline each year is April 1st and the deadline for second semester is December 1st.

Proof of Residency

To enroll in Fayette County Public Schools a student must reside within the boundaries of Fayette County. A student must reside with a natural parent or a person who has been granted legal guardianship, or the student must be under the care of a state agency with placement in Fayette County.

Proof of residence is required when a student initially enrolls in a school and whenever a change of residence occurs. The Welcome Center will accept the following records as proof of residency:

1. **“Homeowner”**: A current residential property tax statement (If there is not a tax bill, the purchasing/closing information for the residence can be used). The record must include the name of the parent/guardian, a current electric or gas utility bill/initiation of utility service and a photo ID.
2. **“Renters”**: A current lease or rental agreement consisting of the written evidence that the agreement is valid. The record must include the name of the parent/guardian, a current gas or electric utility bill/initiation of utility service and a photo ID.
3. **“Non-Renters” or “Occupants of another person’s home/residence”**: A designed Fayette County Schools Property Affidavit signed by the parent/guardian, as well as by the home’s occupants and the property owner. The record must include the name of the parent/guardian, the student(s) being enrolled and a photo ID. The property owner must also provide the documents noted above.

For your convenience, registration is available at the Welcome Center, located at 205 LaFayette Avenue, Fayetteville, GA 30214. Registration is not available at the schools. Please contact the **Welcome Center at 770-460-3990 x 450**.

Proof of residence is subject to investigation. Students enrolled under false information are illegally enrolled and will be withdrawn from school. Also, knowingly and willfully providing false information regarding proof of residence violates state law and may subject one to fine and /or imprisonment (O.C.G.A. 16-10-20).

Attendance Information

School Attendance

Compulsory Education Law (O.C.G.A. 20-2-690.1) requires that every parent/guardian or other person who has control of any child between the ages of 6 and 16 shall enroll and send such child to school. All children enrolled for 20 calendar days or more in the public schools of this state prior to their seventh birthday shall become subject to the provisions of the compulsory school attendance law. State Board of Education policy defines the school year as 180 attendance days.

Full Day Attendance

Students are expected to be in attendance for the full school day. Students who check-in late or check-out early should submit a written note from their parent/guardian explaining their absence. Disciplinary action may be taken against students not in attendance for the full school day for reasons that cannot be excused.

Student Absences

Whenever students are absent, for any reason, their parent/guardian must send a signed and dated written explanation of the absence to their child’s teacher no later than the **Third Day** following the students return to school after their absence. After five (5) personal notes written by the parent/guardian for excused absences, the school administration may request appropriate medical documentation upon return to school for the purpose of validating the absences.

Excused Absences

As permitted under the state law and State Board of Education policies, students may be excused lawfully for the following reasons: illness, death in immediate family, religious holiday, and instances in which attendance could be hazardous as determined by Fayette County Public School System, services as page in legislature, a court order, absence to vote in an election, and up to five (5) days excused absences per year to students where parents are in the military and are being deployed or are on leave.

Unexcused Absences

Unexcused absences will be subject to attendance investigation and can result in penalty as imposed by the Compulsory Education Law (O.C.G.A. 20-2-690.1) and Student Attendance Protocol Committee Law (O.C.G.A. 20-2-690.2);

- A. Schools will notify by first class mail parents of students ages 6-16 who have accumulated five (5) unexcused absences per semester and will include a copy of the summary of consequences.
- B. The Attendance/Residency Officer of Fayette County Public Schools will notify by letter parents/guardian of students ages 14-17 who have accumulated seven (7) unexcused absences per school year and will include a copy of (O.C.G.A. 40-4-22) the attendance-drivers license law and a summary of consequences.
- C. The Attendance/Residency Officer of Fayette County Public Schools will notify by letter parents/guardian of students ages 6-16 who have accumulated ten (10) unexcused absences per semester and will report violations to the Student Attendance Protocol Committee to determine if court action will be pursued for formal intervention.
- D. State law requires an unemancipated minor over sixteen (16) years of age must have written permission from his or her parent/guardian prior to withdrawing from school.

Reporting Students with Unexcused Absences (O.C.G.A. 20-2-701)

Consequences for Unexcused Absences

- Any parent, guardian, or other person who has control of any child who on the tenth unexcused day of absence per semester, and after the child's school system has notified the parent/guardian, or other person who has control of any child, of each day's absence from school, shall be guilty of a misdemeanor, and court action may be pursued for formal intervention.
- **Penalties:**
 - 1) **Fine** – not less than \$25 and not greater than \$100.00
 - 2) **Imprisonment** – not to exceed 30 days
 - 3) **Community Service**, Or any combination of such penalties, at the discretion of the court.

Tardiness

Students are expected to arrive at school on time. Students who are tardy for school must go to the school office to sign-in before going to class.

- A. Schools will notify by first class mail parents of students ages 6-16 who have accumulated five (5) unexcused tardies per semester.

Attendance/Discipline and Driver's License – (O.C.G.A. 40-5-22)

This law requires that the local school system's central office receive information from the public schools and home schools regarding students 14 through 17 years of age whose driver's licenses are to be revoked or not issued according to the provisions of the law.

Committing any of the following offenses will result in the Georgia Department of Driver Services not issuing an instructional permit or driver's license. If a student has already been issued an instructional permit or driver's license, the department will suspend that permit/license or the ability to receive one, for a period of **one year**. This notification will be made by certified mail if a student

- A. Has dropped out of school without graduating and has remained out of school for ten consecutive school days;
- B. Has **ten or more** school days of **unexcused absences** during the current academic year or ten or more school days of unexcused absences in the previous academic year;
- C. Has been found in violation by a hearing officer, panel, or tribunal of one of the following offenses, has received a change in placement for committing one of the following offenses, or has waived his/her right to a hearing and pleaded guilty to one of the following offenses:
 - I. Threatening, striking or causing bodily harm to a teacher or other school personnel;
 - II. Possession or sale of drugs or alcohol on school property or at school sponsored event;
 - III. Possession or use of a weapon on school property or at school sponsored event.
 - IV. Any sexual offense prohibited under Chapter 6 of Title 16;
 - V. Causing substantial physical or visible bodily harm to or seriously disfiguring another person, including another student.

Students applying for an instruction permit or driver's license must obtain from their school a letter certifying that none of the above provisions apply to them at the time the letter is generated or for the preceding year. All students who intend to get their learner's permit or driver's license over the summer months **must** receive a "Certificate of Attendance" from the school administration prior to the end of the school year. This certificate is **required** when applying for either license. Please check with your school's administration during the month of May.

Exam Exemption Applies to High School Students Only

Attendance

In an effort to encourage and reward excellent attendance at the high school level, a student may exempt any **one** final exam provided he/she meets the following criteria:

- The student must not have been absent from school, checked in late, or signed out early, a combined total of more than five (5) times during a semester for any reason (excused or unexcused). **Checking in and out on the same day counts as only ONE attendance event.**
- The student must have a semester average of at least 71 in the course he or she wishes to exempt.
- The student must not have been tardy to the class he or she wishes to exempt.
- The student must have been enrolled on the first day of each semester in order to exempt an exam.
- Out-of-School Suspension (OSS) counts as an occurrence for attendance exemption.

Academic

As a reward for academic excellence, a student may choose to exempt up to two final exams provided he or she has a grade point average of 95 or better in the class(es) to be exempted.

- If a student qualifies for both attendance and academic exemptions, he or she must choose only one type of exemption (academic or attendance). A student may not choose both.
- A student may **not** exempt one of the state required End of Course Exams (Algebra I, Geometry, U.S. History, Economics, Biology, Physical Science, 9th Grade Lit./Comp. and American Lit./Comp.)

Senior Exam Exemption

A high school senior who will be graduating at the end of the semester may exempt the exam in any course(s) provided he/she meet the following criteria:

- 80 average or higher
- Not absent from school, checked in late, signed out early, a total of more than five (5) times for any reason (excused or unexcused)

(Checking in and out on the same day counts as only **ONE** attendance event)

Civility Policy

Members of the Fayette County School District staff should treat parents and other members of the public with respect and expect the same in return. The district is committed to keeping schools and administrative offices free from disruptions and to preventing unauthorized persons from entering schools or school board property.

Accordingly, employees are expected to follow practices that promote mutual respect, civility and orderly conduct among district employees, parents, and the public in an effort to maintain a safe, harassment free workplace for our students and staff. It is not intended to deprive any person of his or her right to freedom of expression. In the interest of presenting teachers, other employees, parents and other adults as positive role models, the school system encourages positive communication and discourages volatile, hostile, or aggressive actions. The school district seeks public cooperation with this endeavor.

Disruptive Individuals Must Leave School Property. Any individual who disrupts or threatens to disrupt school or office operations, threatens the health and safety of students or staff, willfully causes property damage, uses loud and/or offensive language that could provoke a violent reaction, or who has otherwise established a continued pattern of unauthorized entry on school district property, should be directed to leave school or school district property promptly by the school's principal or other chief administrative officer.

Directions to Staff in Dealing with Abusive Individuals. If any member of the public uses obscenities or speaks in a demanding, loud, insulting, and/or demeaning manner, the administrator or employee to whom the remarks are directed should calmly and politely warn the speaker to communicate civilly and, where appropriate, remind the speaker of the presence of students. If the abusive individual does not stop the behavior, the district employee may verbally notify the abusing individual that the meeting, conference, or telephone conversation is terminated; and, if the meeting or conference is on district premises, the employee shall direct the abusive individual to leave promptly. If necessary, the assistance of administrators or school resource officers should be sought. The employee may be asked to provide a written report of the incident.

This policy is based on Georgia Laws (O.C.G.A. 20-2-118 Disrupting Public School) and (O.C.G.A. 20-2-1182 Persons other than students who insult or abuse school personnel).

Complaints of Discrimination/Harassment

The Fayette County School District does not discriminate on the basis of race, color, religion, national origin, age, disability or gender in employment decisions or educational programs and activities, including its athletic programs. Any student, employee, applicant for employment, parent or other individual who believes he or she has been subjected to harassment or discrimination by other students or employees of the school district based upon any of the factors previously listed should promptly report the same to the principal of the school or the appropriate coordinator as listed below, who will implement the board's discriminatory complaints or harassment procedures. Students may also report harassment or discrimination to their school counselor.

Sports Equity Coordinator – C.W. Campbell, 205 LaFayette Avenue, Fayetteville, GA 30214, 770-460-3990, Ext. 167.

Students and employees will not be subjected to retaliation for reporting such harassment or discrimination. A copy of the discriminatory complaints procedure under Fayette County Board of Education Policy GAAA/JAA (Equal Opportunity/Discriminatory Complaints Procedure) or under Policy IDFA/MDBA (1) (Interscholastic Athletics) is located in the school district policy manual that is available in either the school office or the central office.

Graduation Exercise Participation

Students suspended or expelled through the second semester of their senior year will not be allowed to participate in any school-sponsored activities, including the prom, graduation exercises, or baccalaureate ceremonies.

Parent Involvement

This Code of Conduct is based on the expectation that parents, guardians, teachers and school administrators will work together to improve student behavior and academic performance. School administrators recognize that two-way communication through personal contacts is extremely valuable; therefore, they provide information to parents as well as on-going opportunities for school personnel to hear parents' concerns and comments. Parents and students should contact the principal of the school if specific questions arise related to the Code of Conduct.

Parents are encouraged to become actively involved in their student's educational experience. Some examples of ways to participate are:

- Parent volunteers at the school site
- Parent Teacher Student Organization (PTSO)
- Booster Club membership (academic and athletic)
- Committee participation
- Chaperones (field trips and extracurricular activities)
- Parent/Teacher conferences
- Mentoring

The Code of Conduct specifies within its standards of behavior various violations of the Code which may result in a school staff member's request for a parent or guardian to come to the school for a conference. Parents are encouraged to visit the schools regularly and are expected to be involved in the behavior support processes designed to promote positive choices and behavior. The General Assembly of Georgia requires that this code of conduct include language encouraging parents and guardians to inform their children of the consequences, including potential criminal penalties, of underage sexual conduct and crimes for which a minor can be tried as an adult.

Chronic Disciplinary Student Act (O.C.G.A. 20-2-764)

A chronic disciplinary problem student is a student who exhibits a pattern of behavioral characteristics which interfere with the learning process of students around him or her and which are likely to recur. Georgia law mandates that any time a teacher or principal identifies a student as a chronic disciplinary problem student, the principal shall notify by telephone call and by mail the student's parent or guardian of the disciplinary problem, invite the parent or guardian to observe the student in a classroom situation, and request at least one parent or guardian to attend a conference to devise a disciplinary and behavioral correction plan.

Georgia law also states that before any chronic disciplinary problem student is permitted to return to school from a suspension or expulsion, the school shall request by telephone call and by mail, at least one parent or guardian to schedule and attend a conference to devise a disciplinary and behavioral correction plan.

The law allows a local board of education to petition the juvenile court to require a parent to attend a school conference. If the court finds that the parent or guardian has willfully and unreasonably failed to attend a conference requested by the principal pursuant to the laws cited above, the court may order the parent or guardian to participate in such programs or such treatment as the court deems appropriate to improve the student's behavior, or both. After notice and opportunity for hearing, the court may impose a fine, not to exceed \$500.00, on a parent or guardian who willfully disobeys an order of the court under this law.

Plagiarism

Plagiarism is the representation by a student of another's ideas or writing as his own. Basically, two types of plagiarism are common. The first, which is more serious, involves a deliberate attempt on the part of a student to pass off as his own the writing or ideas of another person (student, parent, published or unpublished author, et al). This type of plagiarism generally consists of the straight copying or slight paraphrasing of a source that the student attempts to conceal. The second results from the student's lack of attention to proper procedures for source acknowledgements and use, involves one or more technical errors. The student in this case fails to acknowledge indebtedness to outside material. Both types of plagiarism are serious violations of the principles of academic integrity. They will not be tolerated. Penalties, especially for those involved in deliberate plagiarism, may be quite severe.

Privacy Issues and Camera Phones/Cameras/Recorders/Cell Phones

The School Board Policy excludes the use of cell phones and other electronic devices at school during the school day because of the interference these devices create to the educational process. The school day begins when the student enters the building and ends when school is dismissed. The use of camera phones, cameras, recorders, or other electronic devices that might violate the privacy rights of students and/or school staff or are used to commit academic fraud will result in appropriate consequences.

Consequences for use of Electronic Devices: **1st offense** – Two days (2) Administrative Detention/Confiscate device and return to parent. **2nd offense** – Three days (3) In-School Suspension/Confiscate device and return to parent. **3rd offense** – 1 day (1) Out of School Suspension/Confiscate device and return to parent. **4th offense and up** – Progressive out of school suspension for each individual offense.

School Safety

Bags and Book bags

For safety reasons bags/book bags are not allowed in classrooms. Students must place all bags/book bags in their locker upon arrival at school.

Disruption of Public Schools (O.C.G.A. 20-2-1181)

It shall be unlawful for any person to disrupt or interfere with the operation of any public school, public school bus, or public school bus stop; such interference is grounds for a charge of a misdemeanor of a high and aggravated nature.

Emergency Preparedness Plan/Emergency Drills

The Georgia Emergency Management Agency reviews and approves the school system's comprehensive School Safety Plan and each school's Emergency Preparedness Plan. These plans are coordinated with county, state, and federal emergency plans.

Fire/evacuation drills will be held on a monthly basis. Also, drills for severe weather, lockdown of the school, and bus evacuation will be held at least once each year. Parents should remind their children that during emergency drill students must respond quietly and quickly and must follow the direction given by their teachers and administrators.

Failure to Leave Campus (O.C.G.A. 16-22-35)

Any person who fails to leave the premises when requested to leave any school property and/or returns to any school property after being instructed by school staff or law enforcement to leave the property, is considered trespassing and faces criminal prosecution of a misdemeanor of a high and aggravated nature.

Loitering on School Property (O.C.G.A. 20-2-1180)

It is unlawful for any person to remain within the school safety zone when that person does not have a legitimate cause or need to be present thereon. Students are not allowed to enter the premises of a school other than his/her school unless prior permission is received from an administrator of the school to be visited or unless the school is hosting a school-related function, such as an academic or athletic activity. A student may not enter or remain in any school building on weekends or after school hours without authorization or permission.

School Resource Officer (SRO)

School resource officers are employed jointly by the Fayette County Board of Education and each specific law enforcement agency within the county. Their main purpose is to assist in providing a safe and secure learning environment for students, teachers and staff. They are an excellent resource for teachers, parents and students in dealing with individual problems or questions with respect to delinquency prevention and the law. Consistent with board policy and legal requirements, school resource officers also provide law enforcement support when needed.

As mandated by state law in Georgia, students will be charged and arrested for possession of weapons, as defined in O.C.G.A. 16-11-127.1, for possession of drugs, as defined in O.C.G.A. 16-13-24 through O.C.G.A. 16-13-32, for any felony or designated felony, as described in Title 16 of the Criminal Code of Georgia Annotated, and for causing bodily injury to others, damage to public or private property, and/or causing a major school disturbance, including but not limited to making terrorist threats. Whether or not a student is arrested for fighting, disorderly conduct, and/or disrupting public school is a decision made after a joint consultation between the school principal and the SRO. In all cases involving an SRO, as in all other serious situations at the school, the parents/guardians are notified in a timely manner

School Safety Zones

School safety zones are defined as in, on, or within 1000 feet of any property owned by the school system. It is unlawful for any person to carry, possess, or have under his/her control any weapons or explosive compound while within a school safety zone, at a school building or school function, or on school property, or a bus furnished by the school. Violation is a felony punishable by a fine up to \$10,000.00, imprisonment for not less than two (2) years and not more than (10) years, or both.

Student Emergency Safety Information

It is critical for the school to be able to contact parents at anytime students are at school. The school must have the parents' current address and home, cellular, and business telephone numbers. Emergency contact persons and their telephone numbers are needed in case a parent cannot be reached. This information is required at the time of registration and whenever a change occurs with the parents' address, telephone or emergency contact information.

Visitors Sign-In Upon Entering Schools – (O.C.G.A. § 20-2-1180)

Georgia law requires that visitors, with the exception of students, school system employees, law enforcement officers or other public safety officials in the performance of an emergency call, shall sign in at the designated location, **as stated on posted signs** of any school building, between the official starting and dismissal times and provide a reason for their presence at the school.

The school administrator or designee shall have the authority to ask any visitor to explain his or her presence in the school at any time when the school is in official session. Any person, who does not have legitimate need or cause to be on the premises or on school property and/or who fails to sign-in at the designated location may be in violation of Georgia law and upon investigation, may face criminal prosecution of a misdemeanor of a high and aggravated nature.

Search and Seizure

Searches will be conducted using the following guidelines:

1. Searches may be conducted when there is reason to suspect that school rules have been violated or that the health, safety or welfare of students may be in danger. Searches of individual students may be conducted at any time when school employees have a reasonable suspicion that the student may have violated a law or school rule. A search of personal items may be made without the student being present.
2. Illegal items (firearms, weapons, and drugs) or other possessions reasonably determined to be a threat to the safety and security of others, or that might possibly interfere with school purposes, may be seized by school employees. **Students are advised not to pick up or handle any illegal items.** Touching or handling any contraband constitutes possession, even though the student does not own the item and did not bring it on school property.
3. Items that are used to disrupt or interfere with the educational process will be removed from a student's person.
4. Student book bags and school lockers, desks and other school property may be subject to search without further notice to students or parents. Such searches may be conducted using "drug-sniffing" dogs or metal detectors. **Students are responsible for all items found in their book bags, lockers and desks.** Where applicable, students are required to submit to the school office a key or combination for locks on their lockers.
5. **A student is responsible for all items found in his/her vehicle.** Student vehicles are subject to be searched without notice and may be conducted using "drug-sniffing" dogs.
6. Breathalyzers may be used when reasonable suspicion exists in cases of use of alcohol.
7. Passive Alcohol Sensors may be used to determine if a student is under the influence of alcohol.

Student Dress Code

Fayette County School System students are expected to dress and be groomed in such a way as to reflect neatness, cleanliness, and good taste. Student dress should not distract or cause disruption in the educational program or orderly operation of the school. School administrators will be responsible for determining dress code violations. The principal reserves the right to interpret or add to these provisions as the principal deems to be in the best interest of the school, student or the educational process.

The following outlines ***inappropriate*** school dress:

1. Shirts and/or dresses that do not cover the waist, shoulders and back
(Sleeveless shirts must cover the entire width of the shoulders.)
2. Tank tops/muscle shirts
3. Pants, shorts, slacks, shirts and skirts of inappropriate size and fit or which have holes
(Pants and slacks must not touch the floor.)
4. Skirts, dresses or shorts with hems above the fingertips
5. Exposed undergarments
6. Not wearing proper undergarments
7. Clothing containing inappropriate language; advertisement of drugs, alcohol, tobacco, or sex; suggestive lettering or pictures advocating/glorifying death and/or violence
8. Transparent or mesh clothing without appropriate clothing underneath
9. Trench coats
10. Apparel that is too revealing
11. Clothing that is excessively form fitting (i.e. spandex)
12. Cut-off jeans
13. Sleepwear and/or bedroom footwear
14. Sunglasses (May not be worn inside the buildings.)
15. Wallet chains or other type chains that may be dangerous or disruptive
16. Hats, caps or hoods
(Hats or caps must be stored in a locker and retrieved at dismissal.)
17. Headbands or bandannas
18. Gang related clothing, signs and symbols
19. Body piercing that is disruptive or dangerous – **(See note below)**

Note: Middle school students are allowed ear piercing only, and high school students are allowed body piercing that is not disruptive or dangerous.

Student Clubs and Organizations

All student clubs and organizations must follow guidelines and procedures governing the creation and operation of such clubs, organizations, and groups in accordance with the policies of the Fayette County Board of Education. State law requires that parents/guardian receive information regarding school clubs and organizations, such information must include the name of the club or organization, mission or purpose, name of the club's faculty advisor, and a description of past or planned activities. Your child's school will provide this information as a supplement to this code of conduct. On the parent/guardian signature page the parent/guardian will have an opportunity to decline permission for his or her student to participate in a club or organization designated by him or her.

Student Support Process

The Fayette County Board of Education provides a variety of resources which are available at every school within the district to help address student behavioral problems. The school discipline process will include appropriate consideration of support processes to help students resolve such problems.

The following is a list of student support resources/programs that may be available to parents and students in the Fayette County School System:

Children at Risk in Education (CARE) – A program that is a committed system of reaching out to students who are experiencing social, emotional, or behavioral difficulties which prevent them from achieving academic success.

Character Education Program – The process of shaping long-standing habits that reflect positive character traits.

Community Mentors – Individuals recruited and trained by the Community Schools mentoring program called FRIENDS. Mentors must meet with student regularly and work to develop a supportive, nurturing relationship.

Drug Abuse Resistance Education (DARE) – A series of ten lessons planned to help strengthen the skills and understandings that enable individuals to recognize and resist the pressures that influence students to experiment with tobacco, alcohol, marijuana, inhalants, and other drugs.

Ghost-Out – (This is implemented at the high school level.) – Alcohol and other drug awareness program. Includes a car crash reenactment.

Interpersonal Cognitive Problem Solving Program (ICPS) – A program with instruction by the classroom teacher for classroom learning.

Literacy Action – A group of trained individuals to assist students with developing reading skills.

New Student Club – A peer program which assists new students in making the necessary adjustment to transition into a new school setting.

Parent Education Series – Ninety-minute parent information programs where various topics such as “The Three R’s – Respect, Resiliency and Responsibility” are presented by guest speakers.

Parent Resource Center – Books, audiotapes, videotapes, etc. that are purchased by CARE and managed by the school CARE Team.

Parent Tutors – Parents who volunteer to tutor students in a supervised school setting.

Peer Mediation – Conflict resolution program where students are trained to help other students resolve their problems. The emphasis is on “I” messages and reflective listening skills. Problems may include name-calling, rumors, teasing, etc.

Rachel’s Challenge – A character education/violence prevention program for grades 4-12. The focus is on teaching inclusion, acceptance, tolerance and diversity.

Rainbow/Spectrum – Twelve-week small group program for grief and loss issues. Teachers and staff are trained as facilitators. Multiple groups are conducted simultaneously.

School Counselor, Psychologists, and Social Workers – These individuals provide student assistance at the school level.

Second Step – A violence prevention program that focuses – on changing student attitudes and behavior that contribute to violence with a focus on anger management, problem solving, and empathy development.

Student Assistance Program (SAP) – A program that provides prevention and intervention training, support and technical assistance to school, community, and agency leaders who assist students and their families in making drug-free and healthy choices for personal success.

Student Mentors – High school students share time with elementary students. Activities may include reading, board games, talking etc.

Student Support Team (SST) – The purpose of this team of professionals is to recommend alternative instructional strategies for students who are having behavioral or academic difficulty in school. Students can be referred to the Student Support Team (SST) by parents, teachers, or other staff. Upon referral, all available information about the individual student will be reviewed and considered to explore a wide range of educational options including special placements.

Systematic Training for Effective Parenting (STEP) – A ten week course offered at night with a focus on praise versus encouragement, punishment versus discipline, goals of misbehavior and ownership of problem.

Teacher Mentors – Teachers who volunteer to mentor a student by agreeing to see the student, at least briefly, every day, and to spend 30 minutes with the student in a supportive activity once a week.

Teacher Authority to Remove Disruptive Students from the Classroom – (O.C.G.A. § 20-2-738)

The board of education, superintendent and local school principals fully support the authority of a teacher to remove from his or her class a student who repeatedly or substantially interferes with the teacher's ability to communicate effectively with the students in the class or with the ability of the student's classmates to learn. Also, if the teacher determines that the behavior of the student poses an immediate threat to the safety of the student's classmates or the teacher, the student can be removed. The school administration will follow the procedures outlined by state law and local board of education policy in determining the consequences and/or placement of the student.

Electronic Network Resources – Appropriate Use (Fayette County Board Policy IFBG)

The Fayette County School System believes that the use of technology for the purpose of information acquisition, retrieval, manipulation, distribution, and storage is an important part of preparing students to live in the 21st century. The Board further believes that a technology rich classroom can significantly enhance both the teaching and learning process. This technology includes computer hardware, software, local and wide area networks, and Internet access. Due to the complex nature of these systems and the magnitude of information available via the Internet, the Fayette County Board of Education believes guidelines regarding acceptable use are warranted in order to serve the educational needs of students.

With respect to any computers belonging to the school and having access to the Internet, it shall be the policy of the Fayette County Board of Education that the school system shall have in continuous operation:

1. A qualifying technology protection measure, as that term is defined in Section 1703(b) (1) of the Children's Internet Protection Act of 2000; and
2. Procedures or guidelines developed by the superintendent, administrators, and/or other appropriate personnel which provide for monitoring the online activities of users and the use of the chosen technology protection measure to protect against access through such computers to visual depictions that are (i) obscene, (ii) child pornography, or (iii) harmful to minors, as those terms are defined in Section 1703(b) (1), and (2) of the Children's Internet Protection Act of 2000. Such procedures or guidelines shall be designed to:
 - a. Provide for monitoring the online activities of users to prevent, to the extent practicable, access by minors to inappropriate matter on the Internet and the World Wide Web;
 - b. Promote the safety and security of minors when using electronic mail, chat rooms, and other forms of direct electronic communications;
 - c. Prevent unauthorized access, including so-called "hacking", and other unauthorized activities by minors,
 - d. Prevent the unauthorized disclosure, use, and dissemination of personal identification information regarding minors online, and
 - e. Restrict minors' access to materials "harmful to minors" as that term is defined in Section 1703(b) (2) of the Children's Internet Protection Act of 2000.

The technology resources are provided for educational purposes that promote and are consistent with the instructional goals of the Fayette County School System. Use of computers and network resources outside the scope of this educational purpose is strictly prohibited. Students and employees accessing network services on any school computer shall comply with the district's acceptable use guidelines. The district reserves the right to monitor, access, and disclose the contents of any user's files, activities, or communications.

It must also be understood that the Internet is a global, fluid community, which remains largely unregulated. While it is an extremely valuable tool for educational research, there are sections that are not commensurate with community, school, or family standards. It is the belief of the Board that the Internet's advantages far outweigh its disadvantages. The Fayette County Board of Education will, through its administrative staff, provide an Internet screen system which blocks access to a large percentage of inappropriate sites. It should not be assumed, however, that users are completely prevented from accessing inappropriate communications or from sending or receiving objectionable communications.

Additionally, access to the Internet and computer resources is a privilege, not a right. Therefore, users violating the Fayette County Board of Education's acceptable use policy shall be subject to revocation of these privileges and disciplinary action.

Student Network and Internet Acceptable Use Agreement

The school's computer network, Internet access facilities, computers and other school equipment/devices are for educational purposes appropriate to the school environment. This applies whether the equipment is owned or leased either partially or wholly by the school, and used on or off the school site.

Definitions Used In this Acceptable Use Agreement

1. **Equipment/devices** - used in this document, includes but is not limited to, computers (such as desktops, laptops, PDAs), storage devices (such as USB and flash memory devices, CDs, DVDs, floppy disks, iPods, MP3 players), cameras (such as video, digital, webcams), all types of mobile phones, gaming consoles, video and audio players/receivers (such as portable CD and DVD players), and any other, similar, technologies as they come into use.
2. **Network** - refers to the school's computer network – both the physical wiring, electronic equipment and the software used to create the connections, Internet access facilities, computers, and other school equipment/devices as outlined in (1) above.
3. **Network/Internet Guidelines Internet** – the user is expected to use the network and all equipment/devices as an educational resource. The following procedures and guidelines are used to help ensure appropriate use of the network at all Fayette County Board of Education locations.
 - I cannot use the school network or equipment/devices until my parent and I have read and signed my Code of Conduct and returned it to school.
 - If I have my own user name, I will log on only with that user name. I will not allow anyone else to use my user name. I will not tell anyone else my password.
 - I understand that I can only use the Internet at school when supervised and with permission.
 - I understand that I must not download any files such as music, videos, games or programs without the permission of a teacher.
 - I understand that these rules apply to any privately owned equipment/device (such as but not limited to: a laptop, mobile phone, USB drive) I bring to school or a school-related activity. Any images or material on such equipment/devices must be appropriate to the school environment.
 - I will not connect any device (such as a USB drive, camera or phone) to, or attempt to run any software on, school without a teacher's permission. This includes all wireless technologies.
 - I will ask a teacher's permission before giving out any personal information (including photos) online about myself or any other person. I will also get permission from any other person involved. Personal information includes name, address, email address, phone numbers, and photos.
 - I understand the school uses filtering software to restrict access to some sites, monitors network traffic, and may audit its computer network, Internet access facilities, computers and devices, and any stored content.
 - I will respect all network systems in use at school and treat all equipment/devices with care. This includes:
 - a. Not intentionally disrupting the smooth running of any school systems
 - b. Not attempting to hack or gain unauthorized access to any system
 - c. Possession of hacking software and tools will be treated the same as an attempt to hack or gain unauthorized access to any system
 - d. Following all school rules, and not joining in if other students choose to be irresponsible with equipment/devices.
 - e. Reporting any breakages/damage to a teacher or staff member.
 - While at school, I will not:
 - a. Access, or attempt to access, inappropriate, age restricted, or objectionable material
 - b. Download, save or distribute such material by copying, storing, printing or showing it to other people
 - c. Make any attempt to get around or bypass security, monitoring and filtering that is in place at school.
 - If I accidentally access inappropriate material, I will:
 - a. Not show others
 - b. Turn off the screen or minimize the window and
 - c. Report the incident to a teacher immediately.

I understand that if I violate these rules, the school may take disciplinary action against me. I also understand that my family may be charged for repair costs. If illegal material or activities are involved, it may be necessary for the school to inform the police.

Medication Policy

It is the policy of the Fayette County School District that the administration of medication by the staff members of the Fayette County Schools to students shall be permitted if it is not feasible for the parent or legal guardian to administer the medication at home. In the event the administering of medication to a student during school hours is necessary, each school will provide appropriate control and assistance in the administration of the medication.

1. The principal or staff member designated by the principal shall be responsible for administration of medication or assistance to the student in self-administration of medication, documentation of administration of medication, and storage of all medications in a locked cabinet.
2. The parent or legal guardian must complete and sign an authorization for administration of any medication at school detailing the student's physician, medication's name, dosage, and frequency. For a prescribed medication, a licensed physician must also sign the authorization detailing the medication's name, dosage, time of administration, and potential side effects. The medication will be administered only in accordance with the written instructions from the prescribing physician. The parents or legal guardians shall authorize the staff member assisting with the administration of medication to correspond directly with the student's physician in the event the staff member deems it appropriate or necessary. The parent/guardian should also be contacted as soon as possible if this should occur. Only medical information related to this instance shall be discussed.
3. All medications and corresponding authorizations must be brought to the school office or clinic by a parent or legal guardian or other designated adult. In the event that a parent or legal guardian cannot bring the medication to school, it is the parent or legal guardian's responsibility to notify the school. The principal or staff member designated by the principal can give approval for the student to transport the medication and authorization to school before the beginning of the school day.
4. All medications must be in their original containers which have unexpired dates, and prescription medications must be clearly labeled with the physician's name, medication's name, strength, dosage, date, time for administration, and dispensing pharmacy. Prescription medication at school shall be limited to no more than a 30-day supply.
5. Under certain circumstances, a student who has a life-threatening condition (i.e. asthma, diabetes, or allergic reaction) may be granted permission to carry medication (such as inhaler, glucose tablet, Epi-pen, or internal insulin pump) on his or her person. Such permission will be granted only in response to a written statement from the student's physician that such a need exists based on a life-threatening condition and a completed and signed authorization from the parent or legal guardian.
6. All medications (prescription and over-the-counter medications) require appropriate authorization (parent or legal guardian and/or physician) for each new school year or whenever there are changes in the student's medication to be administered at school.
7. Any student not complying with this policy and possessing any medication (prescription or over-the-counter medications) on the school campus shall be subject to discipline as set forth in Fayette County School's *Student Code of Conduct* policy.

Code of Sportsmanship

Sportsmanship can be defined in one word: RESPECT. Respect for ourselves, our schools, and guests to our schools helps build a positive image not only with the community, but also with all those who participate in competitive activities in our schools. Responsibilities of participants and parents:

- Use appropriate language.
- Treat opponents with the respect due them as guests or hosts.
- Exercise self-control at all times.
- Respect the officials' judgment and interpretation of the rules.
- Respect the coaches' judgment and authority.
- Accept the responsibility of representing your school in a positive manner.
- Act in a manner that will create a positive attitude in the audience.

Eligibility to Participate in Athletic/Extracurricular Activities

*** Contact the school's athletic administrator to clarify questions concerning eligibility**

Middle School (7th and 8th grade)

- Students must pass all 5 academic subjects the semester preceding participation
- A player must not reach his/her 15th birthday prior to May 1st preceding their 8th grade year. A player must not reach his/her 14th birthday prior to May 1st preceding their 7th grade year
- An eligible student can participate in each sport, once in the 7th grade and once in the 8th grade
- Students must adhere to all rules and regulations outlined in the Athletic/Extracurricular Code of Conduct and/or specific written guidelines developed by the coach and/or school administration
- Middle school athletics is governed by the Fayette County Middle School Athletic League.

High School (9th through 12th grade)

- All first year, first semester 9th grade students are academically eligible.
- Students must pass 5 out of 6 subjects the semester preceding participation.
- A student must not have reached his/her 19th birthday prior to May 1st preceding the year of participation.
- Students must be "on track" for graduation
 - 10th grade students must have accumulated at least 4 Carnegie units
 - 11th grade students must have accumulated at least 10 Carnegie units
 - 12th grade students must have accumulated at least 16 Carnegie units
- A student has 8 consecutive semesters or 4 consecutive years of eligibility from the date of entry into the ninth grade to be eligible for interscholastic competition.
- Students must adhere to all rules and regulations outlined in the Athletic/Extracurricular Code of Conduct and/or specific written guidelines developed by the coach and/or school administration.
- High school athletics is governed by the Georgia High School Association.

Retention for Athletic Purposes

A student will not be retained in any grade for athletic purposes.

No person in the Fayette County School System shall, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination in any education program or activity receiving financial assistance.

FAYETTE COUNTY SCHOOL SYSTEM
ATHLETIC AND EXTRACURRICULAR PARTICIPATION
CODE OF CONDUCT CONTRACT

Interscholastic extracurricular programs are a vital part of the total educational program and a means of developing wholesome attitudes and good human relations, as well as knowledge and skills. The Fayette County School System encourages participation in a variety of extracurricular activities.

Participation in school athletic and extracurricular activities is a privilege and not a property right. All students, parents, coaches, and sponsors understand that the top priority is academic achievement. The purpose of the Code of Conduct is to establish high expectations regarding behavior and minimum/consistent consequences when violations occur. However, **coaches/sponsors may establish consequences that are more stringent than the stated code.** Team/organization rules must be in writing and approved by the administration of each school.

CODE OF CONDUCT VIOLATIONS AND CONSEQUENCES

VIOLATION: Students enrolled in Alternative School/Long-Term Suspension
CONSEQUENCES: Ineligible to attend or participate in any athletic or extracurricular activity.

VIOLATION: Arrest for Felony (regardless of location or time of the alleged act; in or out of school)
CONSEQUENCES: Immediately suspended from all participation pending investigation by school officials.

For violations below, a school administrator must have valid evidence and/or verification of the violation as defined in the following:

1. Self-admitted involvement by the student.
2. Witnessed student involvement by the sponsor, coach, or any staff member.
3. Parent admission of their student's involvement in tobacco, drugs, or alcohol.
4. Verified by official police report given to the school.
5. Evidence of violations through investigation by school officials.

If this offense occurs at school or on school property at any time, off the school grounds at a school-sponsored activity, function, or event, and en route to and from school, the student will be subject to the actions of the Fayette County School System Student Code of Conduct.

VIOLATION: Alcohol/Drugs
CONSEQUENCES: Coach/sponsor will meet with the student and parents.
1st Offense- suspension from any athletic/extracurricular activity for 25% of the season
2nd Offense- one (1) calendar year suspension from all athletic/extracurricular activities

VIOLATION: Criminal Law Violations (Non-Felony away from school)
CONSEQUENCE: Disposition determined by the coach and school administration based on the severity of the charge(s).

VIOLATION: Tobacco (any type)-In season
CONSEQUENCES: 1st Offense- minimum of one (1) game/activity suspension.
2nd Offense- suspension from any athletic/extracurricular activity for 25% of the season
3rd Offense- dismissed from the team/activity but allowed to try out for subsequent athletic/extracurricular activities after that sport/activity has completed its season.

VIOLATION: Violations of school rules that result in in-school suspension and out-of-school suspension
CONSEQUENCES: Participation may resume when:

ISS all assignments are completed and released from in-school suspension and/or
OSS the student returns to school on the next school day upon completion of out-of-school suspension

Out-of-School Suspension (Short Term—2 or more days)
1st Offense- minimum of one (1) game/activity suspension
2nd Offense- suspension from any athletic/extracurricular activity for 25% of the season
3rd Offense- dismissed from team/activity but allowed to try out for subsequent athletic/extracurricular activities after that sport/activity has completed its season.

VIOLATION: Hazing
CONSEQUENCES: Coach/Sponsor will meet with the student and parents.
1st Offense Suspension from any athletic/extracurricular activity for minimum of 25% of the season
2nd Offense One (1) calendar year suspension from all athletic/extracurricular activities

Progressive Discipline Procedures

When it is necessary to impose discipline, school administrators and teachers will follow an **age appropriate progressive discipline process**. The degree of discipline to be imposed by each school official will be in proportion to the severity of the behavior of a particular student and will take into account the student's discipline history, the age of the student and other relevant factors.

The Code of Conduct provides a systematic process of behavioral correction in which inappropriate behaviors are followed by consequences. Disciplinary actions are designed to teach students self-discipline and to help them substitute inappropriate behaviors with those that are consistent with the character traits from Georgia's Character Education Program. Major offenses including, but not limited to, drug and weapon offenses can lead to schools being named as an Unsafe School according to the provisions of State Board of Education Rule 160-4-8-.16 Unsafe School Choice Option.

Parents and police will be notified in every instance where the law is violated.

Students returning from boot camps, youth detention centers, incarceration, or similar facilities must apply to and successfully complete one semester of Alternative School prior to returning to their regularly assigned school. This process will assist the student in a successful transition back into the regular school environment.

Glossary of Terms

1. **Absence** – A student is considered absent when missing more than one-half of the regular school day.
2. **Alternative School** – A program intended to provide educational opportunities for students in grades 1-12 who have been expelled or suspended long term for disciplinary reasons or have been assigned on a voluntary basis. This program is designed to ensure success of students who may be unlikely, for a variety of reasons, to reach their potential in a traditional setting. Parents must provide transportation for students enrolled in the Alternative School.
3. **Attendance Policy** – (High School only) A student must apply for credit if he/she misses more than 10 days (excused or unexcused) in any one semester. Attendance is compiled period-by-period. Missing more than 15 minutes in any one period is considered an absence.
4. **Bullying** – (OCGA 20-2-751.4) Any willful attempt or threat to inflict injury on another person when accompanied by an apparent present ability to do so; or any intentional display of force such as would give the victim reason to fear or expect immediate bodily harm.
5. **Bus Suspension** – The local school administrator suspends the student from the bus for a specified period of time. The student is expected to attend school, but the parents are responsible for providing transportation to and from school.
6. **Cease and Desist** – Notification to student(s) from the school administration to immediately cease all activity which may be construed as bullying, threatening, intimidating or harassing. This behavior may be written, verbal or implied.
7. **Chronic Disciplinary Student** – (O.C.G.A. 20-2-764)
A chronic disciplinary problem student is a student who exhibits a pattern of behavioral characteristics which interfere with the learning process of students around him or her and which are likely to recur.
8. **Clubs and Organizations** – Are comprised of students who wish to organize and meet for common goals, objectives, or purposes and which is directly under the supervision, direction, and control of the school.
9. **Detention** – A requirement that the student report to a specified school location and to a designated teacher or school official to make up work missed, complete assignments, or to receive specific instruction in behavior modification. The minimum of one (1) day notice will be given. (Detention may require the student's attendance before school, after school or on Saturday.)
10. **Disciplinary Probation** – A student who has violated certain provisions of this code may be placed on probation by the local school administration. Probation is a trial period during which a student violating school and/or school system rules is subject to further disciplinary action.
11. **Disciplinary Tribunal Panel** – A three-member panel composed of an administrator, teacher, counselor, or school official. The Panel hears evidence presented by the school system, the student, and parents when a student is referred by the local school principal or his/her designee. The Panel has the authority to make decisions ranging from returning the student to the local school to recommending permanent expulsion of the student.
12. **Due Process** – A student is afforded oral or written notice of the charges against him/her and is given an opportunity for a review, hearing or other procedural rights in accordance with state and federal laws.
13. **Expulsion** – Removal of a student from the school system for an extended period of time or permanently by a Disciplinary Tribunal. Those expelled will not be allowed on school board property or allowed to attend school sponsored activities.
14. **Hazing** – To subject a student to an activity which endangers or is likely to endanger the physical health of a student, regardless of a student's willingness to participate in such activity.
15. **Individualized Educational Plan (IEP)** – A written statement of special education related services, and, as appropriate, transition services that meet the unique needs of the student with a disability.
16. **In-School Suspension** – The student is removed from regular classes for a specified period of time at the local school. Class work assignments are sent to the student by the teachers. Students are excluded from all school-sponsored activities until completion of the assigned days.
17. **Pre-arranged absence** – A written request made by the parents to the principal requesting permission for their child to be absent from school in order to take an educational related trip. A pre-arranged absence form must be completed and approved prior to being absent.
18. **Restitution** – Full payment for damages or replacement cost.
19. **Saturday School** – An instructional activity held on Saturday which allows a student to make up work that was assigned while they were absent during the regular school day or an optional discipline strategy that may be assigned by building level administrators to address certain school discipline infractions.
20. **Short-Term Suspension (Out-of-School Suspension)** – The student is suspended out-of-school up to ten (10) days by the local school administrator. The student may be suspended for an accumulation of offenses, as well as a major offense. During the term of suspension the student is not allowed on the school property or any Board of Education property, or at any school activity or school-sponsored event.
21. **Substance Use Prevention and Education Resource Program (SUPER I)** – Family-based drug education program available in four two hour sessions designed to provide substance abuse information for students and their parents. S.U.P.E.R. is used as a positive counseling resource.
22. **Transmission** – The passing of any substance, article, or weapon to another person.
23. **Truancy** – The student stays out of school without permission or valid excuse.
24. **Waiver of Right to Attend Student Disciplinary Tribunal** – Parents may sign a waiver if they cannot attend or choose not to contest the charges. By signing this waiver, the student and parent admit to the charges outlined in the superintendent's letter, and accept the assigned consequences. The waiver eliminates the tribunal process. In the event a parent or student does not attend the hearing, it will proceed as scheduled.
25. **"504"** – Section 504 of the Rehabilitation Act of 1973 requires that a free and appropriate education be provided to each student within its jurisdiction who has been identified as handicapped within the definition provided by this act.

Family Educational Rights and Privacy Act (FERPA)

The Family Educational Rights and Privacy Act (FERPA) affords parents and students over 18 years of age or an emancipated minor under State Law (“eligible students”) certain rights with the respect to the student’s education records. These rights are:

1. The right to inspect and review, within 45 days of a request, the educational records of a student who is your child, or in the case of a student who is eighteen (18) or older, or those who are emancipated, your own educational records. Parents or eligible students should submit to the principal a written request identifying the record(s) they wish to inspect. The principal will make arrangements for access and provide notice of such arrangements
2. The right to request the amendment of the student’s educational records to ensure that they are not inaccurate, misleading, or otherwise in violation of the student’s privacy or other rights. To request the school district to amend a record, parents or eligible students should write the school principal, specify the part of the record they want changed, and specify why it is inaccurate, misleading, or otherwise in violation of the student’s privacy or other rights. If the district decides not to amend the record, it will notify the parents or eligible students of the decision and inform them of their right to a hearing. Additional information regarding the hearing procedure will be provided with the notification of the right to a hearing.
3. The right to file a complaint with the United States Department of Education concerning the alleged failures by the Fayette County Board of Education to comply with the requirements of FERPA. The name and address of the Office that administers FERPA is Family Policy Compliance Office, U.S. Department of Education, 400 Maryland Avenue, SW, Washington, D.C. 20202-5920
4. The right to consent to disclosures of personally identifiable information contained in the student’s educational records, except to the extent that the Act and the regulations promulgated pursuant to the Act authorize disclosure without consent. One exception, which permits disclosure without consent, is to school officials with legitimate educational interest. A school official is a person employed by the district as an administrator, supervisor, instructor, or support staff member; a member of the school board; a person with whom the district has contracted to perform a specific task (such as attorney, auditor, or therapist); or a parent or student serving on an official committee (such as a disciplinary or grievance committee.) A school official has a legitimate educational interest if the official needs to review an educational record in order to fulfill his/her professional responsibility. Upon request, the school district forwards educational records without prior consent to another school in which the student seeks or intends to enroll. In addition, attendance and disciplinary information will be shared with the Georgia Department of Driver Services, pursuant to Sec. O.C.G.A. 40-5-22.

Release of Student Directory Information

The Fayette County School District has designated the following student-based information as “directory information” under the provisions of the Family Educational Rights and Privacy Act (FERPA) and may disclose that information upon request by appropriate institutions/agencies:

- a) Student’s name, address and telephone number;
- b) Student’s date and place of birth;
- c) Student’s participation in official school clubs and sports;
- d) Weight and height of student if he/she is a member of an athletic team;
- e) Dates of attendance at the Fayette County School System;
- f) Awards received during the time enrolled in Fayette County School System;
- g) Grade Level; and
- h) E-mail address

Unless you, as a parent/guardian or eligible student, request otherwise, this information may be disclosed to the public upon request. You have the right to refuse to allow all or any part of the above information to be designated as directory information and to be disclosed to the public upon request. **If you wish to exercise this right, you must notify the principal of the school at which the student is enrolled in writing within 5 days after enrolling in school.**

You are also notified that from time to time students may be photographed, video taped, or interviewed by the news media at school or at some school activity. **If you as a parent/guardian object to your student being photographed, video taped or interviewed, you must notify your student’s principal, in writing, of your objection within 5 days after enrolling in school.**

Release of Information to the Armed Forces:

Relative to HS juniors and seniors, school systems are required by federal law to provide the United States military recruiters, upon request, student directory information on an annual basis for recruiting purposes.

“Opt-out-Privileges”:

Under current federal law, any parent/guardian or eligible student may object to the release of student directory information about an individual student to the United States military recruiters. To request that this information not be released, please signify your “Opt-out” request in the comment section of the Parent/Guardian Signature Page.

Notice to Parents/Guardians and Eligible Student of Rights Under Protection of Pupil Rights Amendment (PPRA)

(1) Parents and eligible students (18 or older or emancipated minors) shall be notified at the beginning of the school year of the approximate dates during the school year when any of the activities listed below are expected to be scheduled. The Board of Education has developed and adopted policies, in conjunction with parents, regarding the activities described in paragraph (1). In accordance with Board policies, prior written consent must be obtained from parents before students are required to submit to any survey that contains questions about one or more of the areas listed in subparagraph (1)(A). You have the right to inspect any survey or instrument used in the collection of information under subparagraphs (1)(A) and (1)(B) before the instrument is administered or distributed to a student and to opt your student out of participation in any activities described in paragraph (1) in accordance with regulations developed by the Superintendent.

(A) The administration of any survey containing one or more of the following items:

- (i) Political affiliations or beliefs of the student or the student’s parent;
- (ii) Mental or psychological problems of the student or the student’s family;
- (iii) Sex behavior or attitudes;
- (iv) Illegal, anti-social, self-incriminating, or demeaning behavior;
- (v) Critical appraisals of other individuals with whom respondents have close family relationships;
- (vi) Legally recognized privileged or analogous relationships, such as those of lawyers, physicians, and ministers;
- (vii) Religious practices, affiliations, or beliefs of the student or student’s parent; or
- (viii) Income (other than that required by law to determine eligibility for participation in a program or for receiving financial assistance under such program).

(B) Activities involving the collection, disclosure, or use of personal information collected from students for the purpose of marketing or for selling that information (or otherwise providing that information to others for that purpose).

(C) Any non-emergency, invasive physical examination or screening that is required as a condition of attendance, administered by the school and scheduled by the school in advance, and not necessary to protect the immediate health and safety of the student, or of other students, but not including hearing, vision or scoliosis screening.

(2) You may, upon request, inspect any instructional material used as part of the educational curriculum for your student.

(3) The school system is required by federal law to give this notice to parents. However, the school system does not have scheduled any such activities as are described in paragraph 1. If any such activities are initiated during the school year, you will be notified accordingly and will be afforded all the rights as described herein.

SCHOOL BUS PROCEDURES

Riding a school bus is a privilege; it is not a required service. Bus suspension is a reasonable and often necessary discipline action. Bus privileges can be suspended either temporarily or permanently.

SCHOOL BUS SAFETY

School bus discipline and school bus safety are intertwined and inseparable. Students must properly ride the bus to ensure everyone's safety including that of other students, motorists, and pedestrians. Conduct that is disruptive or distracting will not be tolerated. All bus safety rules apply to regular bus routes, field trips, and athletic trips.

SAFETY RULES AT THE BUS STOP

- Take the shortest, safest route to the bus stop.
- Be at the bus stop five minutes before time for the bus to arrive.
- Walk on the left shoulder of the road facing traffic unless there are sidewalks.
- Wear light or brightly colored clothing.
- Wait a safe distance from the road, but be prepared to quickly board the bus.
- Respect the property of other people.
- Refrain from pushing, fighting, or any other unsafe activity at the bus stop!
- Report disturbances immediately to school administration for resolution.

SAFETY RULES FOR ENTERING AND EXITING THE BUS

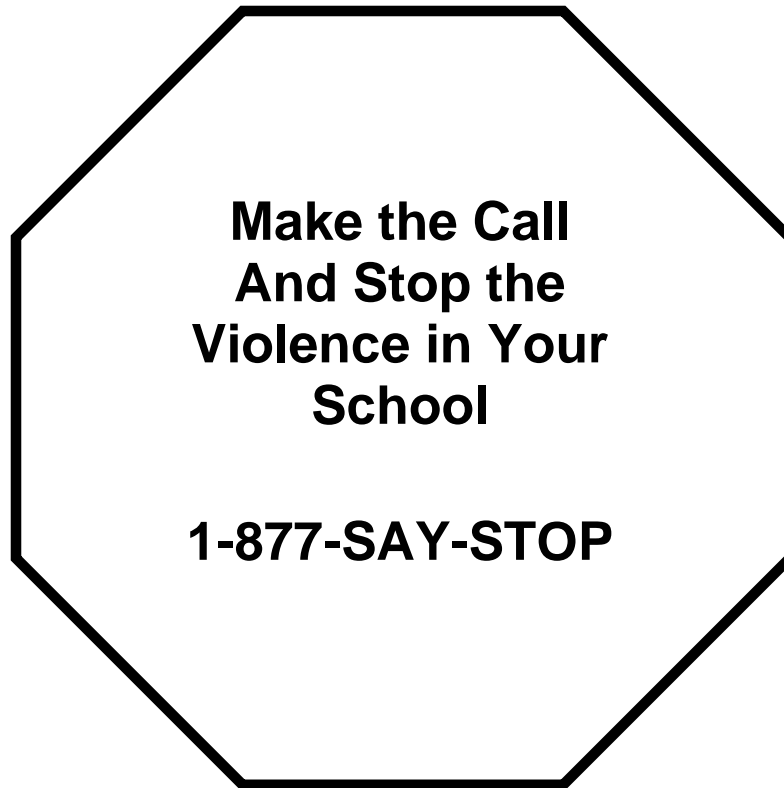
- Be sure all traffic has stopped both ways before crossing the road. (Stop, Look, Listen)
- Walk 10 feet in front of the bus to stay in the driver's view when crossing the road.
- Never cross the road behind a school bus.
- Stop at the centerline of the road and look both ways before crossing after exiting the bus.
- Do not linger in the "Danger Zone" (The "Danger Zone" is a ten foot parameter around the bus where most accidents happen.)
- Do not go back for items dropped in the "Danger Zone" Leave the item. Get the driver's attention before retrieving anything!
- Never stop in the "Danger Zone" to get mail from the mailbox.
- Secure loose items such as toys, key chains, and drawstrings to avoid hanging them on the bus, especially the handrail.

SAFETY RULES ON THE SCHOOL BUS

- Observe the same conduct as in the classroom.
- Go directly to assigned seat when entering the bus. Remain properly seated and keep hands to self.
- Never throw objects in or out of the bus.
- Show proper respect to the bus driver and follow directions.
- Do not eat, drink, chew gum or bring glass objects, nuisance items, animals, tobacco, alcohol, drugs, weapons, cell phones, mirrors, lasers, flash cameras, or any other lights or reflective devices that do or might interfere with the school bus driver's operation of the school bus. Electronic devices such as, but not limited to, cellular phones, pagers, audible radios, tape or compact discs without headphones or any other device that may interfere with the school bus communications equipment or the school bus driver's operation of the school bus are prohibited (OCGA 20-2-751.5).
- Never bring objectionable or dangerous objects such as weapons, glass, skateboards, or large projects on the bus.
- Refrain from using loud voices, profanity and/or obscene gestures, and respect the rights and safety of others.
- Keep totally silent at railroad crossings.
- Stay seated until time to get off the bus.
- Do not tamper with safety equipment including crossing gate, emergency doors, windows or hatches.
- Help keep the bus clean and in good, safe condition.

ADDITIONAL GUIDELINES

- Parents are responsible for providing transportation for students suspended from riding the bus.
- Bus drivers are in complete charge at all times and are authorized to assign seats.
- Conversation with the driver or behavior distracting the driver by students during loading and unloading of buses should be avoided. During this critical time complete concentration by the driver is required.
- Parents with concerns or complaints that need to be addressed by the bus driver should schedule a conference with the driver through the school. Under no circumstances should parents distract the driver by boarding the bus or complaining at the bus stop. Student safety must be top priority during this time.
- Student conduct in school and on school buses may be videotaped with surveillance equipment. This equipment is installed for the purpose of promoting a safe environment for students, personnel, passengers and drivers.
- Any action or disturbance that endangers the well being of any student will be handled in accordance with the student discipline section of this handbook.
